A “Puerto Rican” Styled – Potato Salad You Must Try!

Ingredients

- 4 medium russet potatoes (about 1 ½ lbs.), peeled and cubed
- 1 tablespoon salt
- ½ medium yellow onion, finely chopped (about ½ cup)
- ½ medium red apple, peeled and finely chopped
- 3 hard-boiled eggs, peeled and finely chopped
- ½ cup mayonnaise
- salt and pepper to taste

Instructions

1. Bring large pot filled with water to boil over high heat.
2. Add potatoes and 1 tablespoon salt.
3. Reduce heat to medium.
4. Cook potatoes until fork-tender, about 15 minutes.
5. Drain.
6. In large mixing bowl transfer cooked potatoes to bowl.
7. Set aside until potatoes are just warm.
8. Add onions, apples and eggs to bowl.
9. Add mayonnaise to bowl.
10. Using large spoon, gently stir to combine.
11. Season with salt and pepper to taste.
12. Serve chilled or at room temperature.

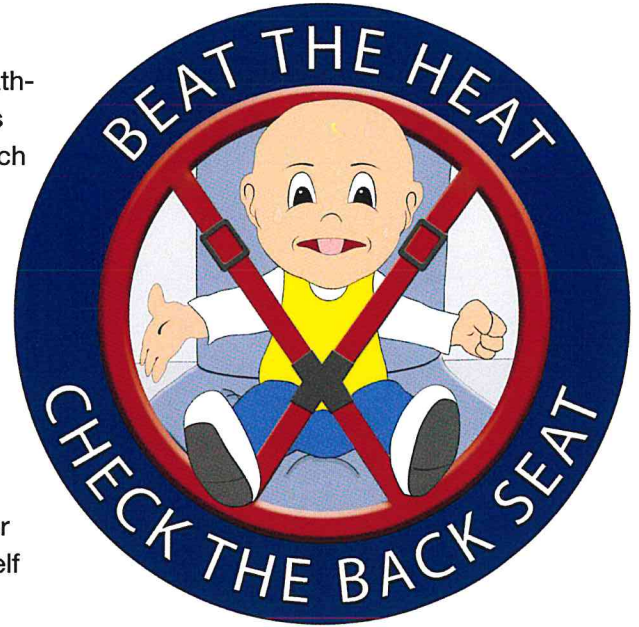
The Heat Is on – Safety Tip

According to the National Weather Service, heat is the number one weather-related killer in the United States, and it results in hundreds of deaths each year. Surprisingly, excessive heat claims more lives on average each year than other seemingly more sinister weather events such as floods, lightning, tornadoes, and hurricanes combined.

Children, Parked Cars, and Warm Temps—a Bad Mix

Leaving children alone in parked vehicles is never a good idea, but it's especially dangerous on warm days. Dozens of children die each year after being left unattended in vehicles, sometimes even when they are left for just a short amount of time. The temperature inside a vehicle—even on a day that's just 80 degrees—can quickly rise to levels well over 120 degrees, leading to heat stroke once the child's body can't cool itself down.

Safe Kids, U.S.A. recommends that you never leave your child alone in a parked car—even for a minute. Always lock unattended vehicle doors and trunks and call 911 immediately if you see a child left unattended in a vehicle. 




Difference Between SSDI and SSI

The two types of disability benefits issued by the Social Security Administration (SSA) are Social Security Disability Insurance (SSDI) and Supplemental Security Income (SSI). Both supplement the incomes of those who suffer from medical disabilities that preclude them from working. The difference between the two is a matter of economic eligibility.

SSDI is funded by payroll taxes paid by employers, employees, and the self-employed. It is available to those who have earned enough work credits based on their lifetime payroll-tax contributions. This means they have been

able to work for a number of years, but can no longer do so due to a physical or mental impairment that is expected to last a minimum of 12 months or until death.

SSI benefits are paid for by general-fund (not the Social Security trust fund) taxes and are not based on a recipient's prior work history. Claimants are those who did not earn enough work credits to qualify for SSDI benefits, live on a very limited income, and have \$2,000 or less in cash or combined bank accounts (\$3,000 for a married couple). SSI benefits are payable to anyone who is age 65 or older, blind (total or legal blindness), or disabled.

The SSA's rules and regulations can be complicated. If you think you may be eligible for SSDI or SSI benefits, contact a Social Security disability benefits attorney to bolster your claim.
